### President's Message

FY 2022/23 saw MILK (Mainly I Love Kids) Fund making significant strides in addressing critical gaps faced by underprivileged youth and children in Singapore.

Our commitment has also grown significantly, with 533 students receiving support from MILK. We have expanded our MILK ITE Scholarship to cover all three ITE Colleges in Singapore. We have 374 new ITE Scholars and 38 Polytechnic and University Scholars. These scholarships have been a lifeline for our beneficiaries, transforming their lives and giving them hope for the future.

This year also saw our first batch of 58 ITE Scholars successfully graduating from their courses. There have been no dropouts from our Polytechnic and University programmes. This underscores the effectiveness of our partnership with FSCs and other key stakeholders. Together, we provide holistic support and a unified front in addressing gaps.

Finally, to further enhance the Scholarship experience, the MILK team hosted over 12 in-person sessions with our MILK scholars and alumni, engaging over 200 beneficiaries. These sessions provided valuable resources that focussed on employability and personal growth.

Our thanks to all our Donors and Volunteers, many of whom who have supported us over the years with their donations and conributions of time. Together, we continue to provide hope for the future!

### MILK (Mainly I Love Kids) Fund

MILK (Mainly I Love Kids) Fund ("MILK" or "MILK Fund"), a charity with IPC status, was founded in 2004. The mission of MILK is to ensure no child is left behind because of disability, illness or circumstance. MILK works towards developing children into contributing members of society. Over the years of serving the community and the needy, MILK programmes continue to plug gaps as well as focus on transforming the lives of those we help. Apart from only giving help at the time of need, we have initiated programmes to help our beneficiaries with the aim of reaching the point of being independent of support from the community.



### Our Mission & Vision

MILK believes that no child should be left behind regardless of disability, illness, or circumstance. At MILK we believe that the best way to commit to our future is through our children. This is why we build-up and work with partners and programmes that develop children into contributing members of society.

MILK operates in a unique partnership Social Service Agencies (SSAs). MILK is committed to advocate and raise funds, supporting our partners so they may best play their role of providing direct services to the children and their families. This is our mission and the way that we achieve results.

MILK focuses on plugging the gaps in the social service sector rather than duplicating what is already in existence, and this is done by an ongoing and rigorous study of the nonprofit landscape and the policies in place. MILK also devotes its resources to transformational programmes that empower children and their families to break out of the poverty cycle.

### Review of financial state, explanation of major financial transactions and purposes for which the charity's assets are held

Total income for the financial year ended 31 March 2023 of S\$590,476 consisted of donations, government grants and other income.

Total expenditure of S\$285,585 was for cost of generating voluntary income, charitable activities, governance costs and other expenditure.

Surplus for the financial year was S\$304,891.







### Programmes

MILK ensures that help provided is holistic and transformational to the families or community by bringing together resources and committed partners.

### The MILK Fund Bursary

The bursary programme provides financial support to students from disadvantaged backgrounds. They cover essential education-related expenses such as school fees, uniforms, stationery, meals and transport expenses. MILK currently partners St. Anthony's Canossian Secondary School in administering the bursary to deserving students.

MILK-CCC Young Minds Support Programme

Since 2021, MILK has partnered with the Counselling and Care Centre (CCC) to pioneer a pilot programme. This programme is designed to extend counselling support to children and youth from financially challenged backgrounds.

The focus remains on addressing their mental health challenges, ensuring their overall well-being. We have further enriched our support landscape by recognizing the pivotal role of counselling for some of our scholars facing challenges in school and at home.

This year, we have witnessed how scholars have proactively sought and benefited from the availability of counselling support. MILK seeks to work in partnership to create an environment of comprehensive well-being for each beneficiary we serve. A total of 32 students benefitted from this programme in the year.

### Make A Difference (MAD) Programme and Scholar Engagement

In FY 2022/23, we extended our efforts through the Make A Difference (MAD) Programme and Scholar Engagement initiatives. Throughout the year, we facilitated a series of 5 interactive engagements, bringing together our current scholars and alumni. Notably, on June 11, 2022, we established the inaugural Scholar Committee. This committee is driven by the shared objective of contributing to the community and orchestrating purposeful engagement events for a broader spectrum of beneficiaries.

### **KeyStart Housing Stability Programme**

Between 2015 and 2017, MILK, in partnership with South Central Community Family Service Centre (SCC FSC), initiated the Keystart Housing Stability Programme to help low-income families with young children out of poverty.

It is a comprehensive assistance scheme for lowincome families with young children. Beneficiaries are families in public rental flats who will benefit from home ownership and families who are at risk of losing their homes due to crisis. The purpose of this programme is to give hope, provide an enabling environment for them to improve their lives and, in particular, that of their children. The stability of having a home of their own away from the delinquent subculture has been shown to have numerous positive effects on young children who then go on to perform better academically and socially. The programme includes financial assistance, financial literacy coaching and family partners (volunteers from the community) - who seek to befriend, support, motivate and create opportunities that enable financial selfsufficiency and other transformative outcomes.

### The MILK Scholarship – MILK Education Fund

Established in 2010, the MILK Scholarship initiative continues to serve its mission to empower young individuals from disadvantaged backgrounds. The programme ensures that deserving youth are not denied from pursuing tertiary education due to financial constraints. The belief underpinning this initiative is that education provides opportunities for our beneficiaries to acquire valuable skills and reach their potential to break out from the cycle of poverty.

MILK Fund expanded the MILK Education Fund together with seven Social Service Agencies (SSAs) in 2015 to support the provision of scholarships for deserving students. These partnerships contribute to a comprehensive and efficient support system. Our collaborators include Bethesda Care Services, Care Corner Singapore Ltd, Kampong Kapor Family Service Centre, Lakeside Family Services, SHINE Children and Youth Services, South Central Community Family Service Centre Ltd, TRANs Family Services.

Through these partnerships, scholarships and bursaries

continue to be administered by our partners. Additionally, MILK has expanded its reach by forging strategic institutional partnerships to broaden deserving students' access to the MILK Scholarship.

Throughout FY 2022/23, the MILK ITE Scholarship provided crucial financial support for ITE students, addressing their immediate financial stress to allow greater focus on their education. With an average of 95% of our ITE Scholars indicating their goal to progress to a diploma, this programme serves to support this endeavour. Ultimately, the goal is for our ITE students to successfully graduate and be in a position to either be gainfully employed or progress further with their education.

Over the year, we deepened our commitment to enhancing the student experience through strengthened collaborations with all local tertiary institutions. We remain dedicated to creating value bv facilitating holistic growth and development among the students we support.

### Community Foundation Singapore (CFS) - MILK Children Fund

In 2012, MILK Fund donated to Community Foundation of Singapore's Donor Advised Fund (DAF), leading to the establishment of the MILK Children Fund. This effort aimed to provide additional backing for programmes designed to effectively address gaps in support for disadvantaged children and youth.

In FY 2022/23, our concerted efforts involved collaborating with diverse stakeholders to extend assistance to a pair of young twin siblings facing severe special needs. These twins also grappled with exceptionally challenging family circumstances. Through the pivotal support offered by the MILK Children Fund, these children gained access to essential transportation aid.

This support facilitated their uninterrupted participation in both their educational pursuits and vital after-school care, thereby promoting their continuous growth. As a result, the twins have exhibited commendable progress, attributed to the consistency and expertise of the educational environment provided to them. 2 Students received exceptional Transport Subsidy Support.

### Background Information, Operating Model and Profiles of Membership and Executive Committee Members

MILK (Mainly I Love Kids) Fund is a volunteer driven organisation with an active Executive Committee that provides support for programmes, in addition to oversight and strategy.

MILK believes that no child should be left behind regardless of disability, illness, or circumstance. That is why we build up and work with partners and programmes that develop children into contributing members of society. MILK's operating model is to advocate and raise funds to support our partners so that they may best play their role of providing direct services to the children and their families. As a result of this operating model, MILK can afford to have a small and stable membership base, with members admitted based on their passion for, and ability to serve, the cause. Since our formation, the total number of members at any point in time has not exceeded 19 members. Our current membership comprises 19 members. Due to the small and stable membership base, of the 19 current members, 10 have been members for 10 years and more.

From these 19 current members, there are 6 members, who are able and willing to devote considerably more time to the cause, that have stepped forward as Executive Committee members.

They are: Mrs Joy Balakrishnan (President); Mr Mah Bow Tan (Vice President); Mr Wendell Wong (Honorary Secretary); Mr Tan Wah Yeow (Honorary Treasurer); Ms Woo Shea Leen (Executive Committee Member); and Mrs Deborah Ong (Executive Committee Member).

Apart from Mr Mah Bow Tan, Mr Wendell Wong, Mrs Deborah Ong and Ms Woo Shea Leen, the remaining 2 Executive Committee members have served more than 10 years on the Executive Committee.

While MILK strongly believes in Executive Committee renewal, the operating model and small and stable membership base of MILK as well as the level of time commitment needed to be given by Executive Committee members, the pace of renewal will be measured and gradual. However, the search for new Executive Committee members is ever on-going and whenever a right candidate comes to the fore, MILK will endeavor to bring in the candidate and renew the Executive Committee.

### **Governance Policies**

### Board governance

- 1. The Board / Executive Committee (Ex-Co) oversees MILK's affairs. Key matters for the Ex-Co include:
  - a. approving broad policies, determining strategies and programme objectives of MILK
  - b. accountability for the management of donations
  - c. approving and monitoring annual budgets
- 2. The Ex-Co meets at least twice a year and other deliberations/decisions are made via electronic methods.

### **Ex-Co composition**

- 1. The Ex-Co comprises 6 members, all of whom are independent.
- 2. Each member has been appointed on the strength of his/her calibre, experience and potential to contribute.
- 3. The Honorary Treasurer may be re-elected to the same post for a consecutive term of office and, not withstanding such consecutive appointments, cannot serve for a continuous period of more than 4 years.

### Fund raising

- 1. The donations received are used in accordance with MILK's regulations and guidelines, unless stated for specific programmes.
- 2. We believe in keeping fund raising costs to the minimum so that the donations may go directly to the children and the programmes that support them.



### **Finance and audit**

- 1. The finance and audit processes are closely monitored by the Ex-Co for adequacy of internal controls.
- 2. Financial statements shall be disclosed to the public and other stakeholders via the annual report or the website.

### Conflict of interest and related party transactions

- 1. MILK has a conflict of interest or related party transaction disclosure process.
- 2. The concerned parties should declare and abstain from voting in any decisions involving related parties or potential conflict of interest.
- 3. The Ex-Co must be informed of all related party transactions and disclosure made in the annual report.
- 4. No appointment of paid staff with close relationship (i.e. those who are more than acquaintances) with current Ex-Co members shall be made unless with the unanimous approval of all Ex-Co members who do not have any conflict of interest.

### **Disclosure and transparency**

- 1. Annual reports are prepared which include up-to-date information on MILK's programmes, activities and finances.
- 2. Audited financial statements and the annual reports are available at MILK's website for donors and other stakeholders.
- 3. Details of donations in kind, sponsored expenses and related party transactions would be disclosed in the audited financial statements and made available at MILK's website.
